#### ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

#### ARTICLE I - NAME AND ADDRESS

#### **ARTICLE II - DURATION**

This corporation shall have perpetual existence, effective upon the filing of these Articles with the Florida Department of State.
