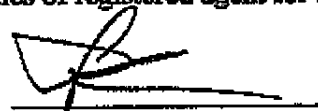

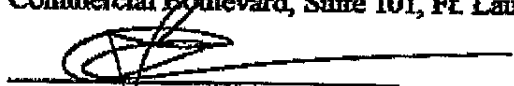
AMENDMENTS
