Dear Sir or Madam:

I am writing to you in response to the recent Notice of Administrative Dissolution or Revocation that was sent out. This served notice that our corporation had been dissolved as of 4 October 2002. The name of our Corporation is the Orlando Celtic Supporters Club, Inc, FEI number 59-3748526.

On reviewing the details contained in the Notice, I find that there is a clerical error in the spelling of my registered address. Instead of the City of abode being stated as Ormond Beach, the Notice incorrectly states that the City of abode is Orlando. The City of abode was correctly identified as Ormond Beach in our original Articles of Incorporation, and I have included a copy of these at Exhibit A for your review. All other details of the address are correct.

I feel that this is the reason that I did not receive the previous two Uniform Business Report (UBR) notices, and I have included the letter stating this at Exhibit B. I have also contacted the Divisions of Corporations, following the instructions in the application for re-instatement. For our date of dissolution, they informed me that our fee for re-instatement would be \$300. I have included a check for this amount in this package.
