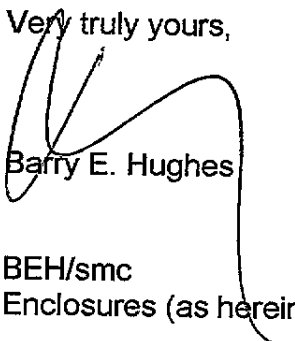

FIRST: Amendment(s) Adopted:

Article One of the Articles of Incorporation is Amended to read in its entirety:

The name of this corporation is NEW SMYRNA REHABILITATION CENTER, INC. with its principal office located at 401 Canal Street New Smyrna Beach, FL 32168.

Article Three (b) of the Articles of Incorporation is Amended to read in its entirety:
