ARTICLES OF INCORPORATION
OF

ARTICLE ONE - NAME

The name of the corporation is KontaktIntelligence.com, Inc.

ARTICLE TWO - DURATION

This corporation shall have perpetual existence.

The corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

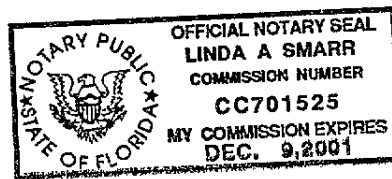
