The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under laws of the State of Florida.

**ARTICLE I – NAME**

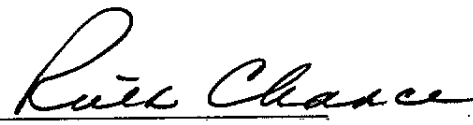
