ARTICLES OF INCORPORATION

The undersigned incorporators hereby form and organize a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is TOUCHTON'S HEATING & AIR CONDITIONING, INC.
