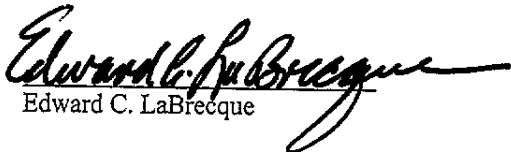

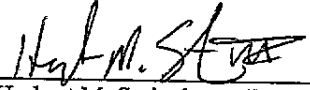

AMENDMENT OF ARTICLES

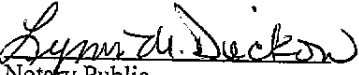
