CORPORATE NAME

CUMULATIVE VOTING FOR DIRECTORS

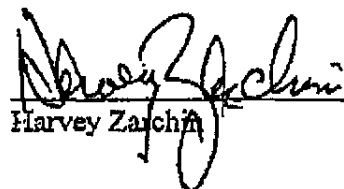

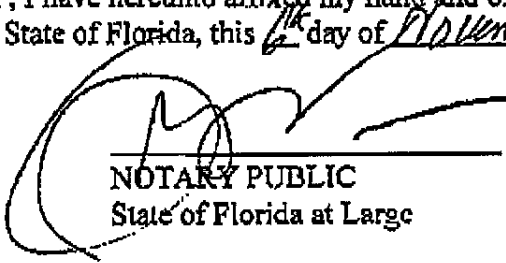
