



ARTICLES OF INCORPORATION OF

ARTICLE I - NAME

The name of this Corporation is ROSEBUD TOURS & TRAVEL INC. _ initial address: 14319 Bending Branch Court, Orlando, Florida 32824.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on November 9, 2001.

ARTICLE VII - BYLAWS


The Bylaws of this Corporation may be adopted, altered, amended or repealed by either the Shareholders or Directors.
