**ARTICLE I
CORPORATE NAME**

The name of this corporation is PKG-GP Acquisition Corporation.

**ARTICLE II
PRINCIPAL OFFICE**

The address of the principal office and the mailing address of this corporation are 11200 Rockville Pike, Suite 220, Rockville, Maryland 20852.

**ARTICLE III
CAPITAL STOCK**

The total number of shares of all classes of capital stock that this corporation shall have authority to issue is One Thousand (1,000), all of which shall be shares of common stock, \$.01 par value per share. All of the common stock herein provided for, when issued, shall have unlimited voting rights, and the common stock shall have the right to receive the net assets of the corporation upon dissolution.

**ARTICLE IV
INDEMNIFICATION**

Stat. §607.0850, as the same may be amended and supplemented, indemnify any and all persons whom it shall have power to indemnify under said section from and against any and all of the expenses, liabilities or other matters referred to in or covered by said section, and the indemnification provided for herein shall not be deemed exclusive of any other rights to which those indemnified may be entitled under any Bylaw, agreement, vote of stockholders or disinterested directors or otherwise, both as to action in his official capacity and as to action in another capacity while holding such office, and shall continue as to a person who has ceased to be a director, officer, employee or agent and shall inure to the benefit of the heirs, executors and administrators of such a person.


