THE UNDERSIGNED, acting as sole incorporator of a professional service corporation to be formed under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

FIRST: The name of the corporation (the "Corporation") is:

SECOND: The initial principal office or mailing address of the Corporation is:

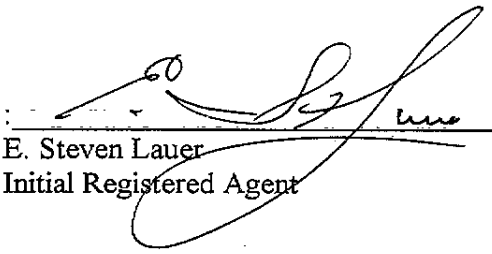
