ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation is J. DANIEL PRODUCE, INC.

ARTICLE II: PRINCIPAL OFFICE

The principal office is 1178 Josephine Court, Sebring, Florida 33870.

ARTICLE III: DURATION

The duration of the corporation is perpetual.

ARTICLE IV: PURPOSE

The general purpose of the corporation is to buy and sell produce and to further engage in any other business services which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business; and engage in and transact any other lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

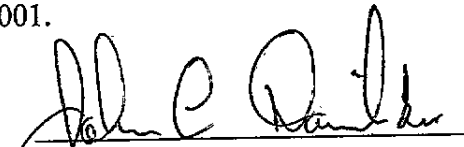
ARTICLE VII: INCORPORATOR

The name and address of the initial Board of Directors of the corporation is John C. Daniel, Sr. Route 1, Box 7, Damascus, GA 31741.

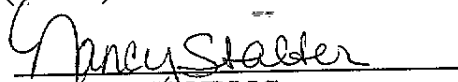
