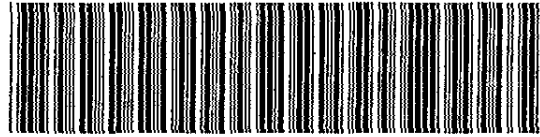

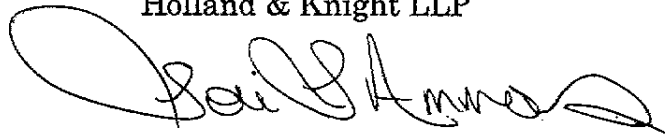

TO THE
ARTICLES OF INCORPORATION
OF

These Articles of Amendment amend the Articles of Incorporation of Big Show Entertainment, Inc. filed with the Secretary for the State of Florida on December 3, 2201, as Document Number P01000114306.

1 Amendment – Change of Corporate Name.

FILM FRAME ENTERTAINMENT, INC.

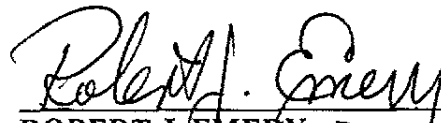
2 Date of Adoption.
