

ARTICLES OF INCORPORATION

OF

The undersigned Subscriber, for the purpose of forming a professional corporation in accordance with Chapter 621 of the Florida Statutes and the Florida Professional Service Corporation Act, does hereby adopt the following Articles of Incorporation.

Article 1 - Name and Address
