The foregoing amendment was adopted by the shareholders of this corporation on the 21st day of January, 2002, and shall be effective as of the 21st day of January, 2002.

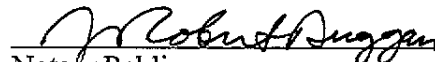
