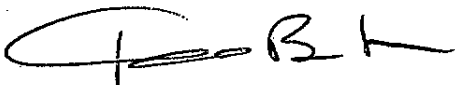

ARTICLE II

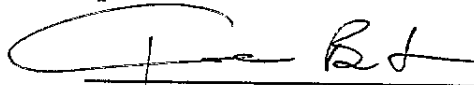

BOARD OF DIRECTORS: The initial board of directors shall consist of ONE (1) member. The name and mailing address of each person who is to service as director is as follows:

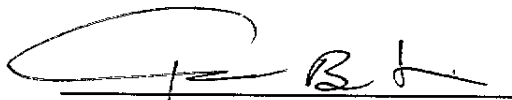
