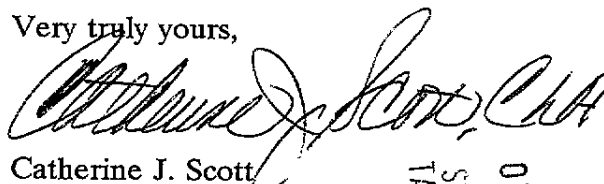

The name of the corporation is:

The name and address of the person signing these Articles is: WILLIAM T. KIRTLEY, 1776 Ringling Boulevard, Sarasota, Florida 34236.

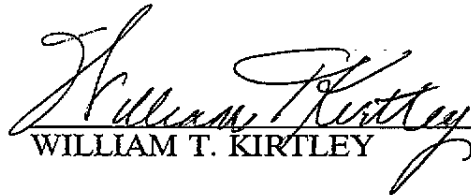
ARTICLE VI - Bylaws
