Ameri-Scape of SW Florida, Inc.

The name of this corporation is Ameri-Scape of SW Florida, Inc.

The nature of the business to be transacted by the corporation is:

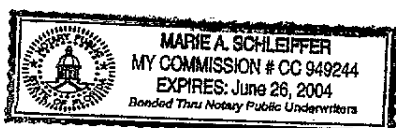
