I, the undersigned, hereby associate for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida providing for the formation of a corporation for profit.

ARTICLE I
Name and Principal Address

The name of the corporation shall be R & P ENTERPRISES OF NORTHEAST FLORIDA, INC., and the principal and mailing address of the corporation shall be 11619 Greenland Hideaway Drive, East, Jacksonville, Florida, 32258.

ARTICLE II
Duration

This corporation shall become effective on January 1, 2002, and shall have perpetual existence thereafter.
