The undersigned incorporator hereby executes and acknowledges these Articles of Correction of the Articles of Incorporation for the purpose of correcting the provisions of the Articles of Incorporation in accordance with Section 607.0124, Florida Statutes and the laws of the State of Florida.

1. The Articles of Incorporation of Teasdale Sontag & Co., Inc. were filed by the Florida Secretary of State on December 26, 2001. A copy of the Articles of Incorporation as filed is attached hereto as Exhibit "A".

2. The incorrect statement in the Articles of Incorporation are contained in Article IV. The description of the shares of stock is not correct.

3. The incorrect statements shall be corrected by completely deleting Article IV of the Articles of Incorporation, and substituting in its place the Article set forth below:

ARTICLE IV.

Shares

The aggregate number of shares of capital stock authorized to be issued by this corporation shall be 100 shares of common stock with a par value of \$0.01 per share. The consideration for the issuance of said shares of capital stock may be paid, in whole or in part, in cash, in promissory notes, in other property (tangible or intangible), in labor or services actually performed for this corporation, in promises to perform services in the future evidenced by a written contract, or in other benefits to this corporation at a fair valuation to be fixed by the Board of Directors. When issued, all shares of stock shall be fully paid and nonassessable.


4. The correction to the existing Articles of Incorporation being effected hereby is that resulting from completely deleting Article IV of the Articles of Incorporation as of the date hereof,
