THIRD REQUEST FOR REINSTATEMENT REQUEST FOR ABATEMENT OF REINSTATEMENT FEE

To Whom It May Concern:

Attached is a copy of your letter dated January 14, 2005, acknowledging receipt and acceptance of a check in the amount of \$150.00 from the above referenced taxpayer, Llerena Enterprises Group, Inc.

Your letter requests a balance due of \$750.00 However, you denied taxpayer's request for abatement and waiver of the \$600.00 reinstatement fee.

Again, please reconsider your decision.

Taxpayer is entitled to an abatement of the \$600.00 re-instatement fee for both of your stated reasons. First, the taxpayer did not receive it Annual Report. Second, the taxpayer was affected by the hurricanes.

Non-receipt of Annual Report

The Florida Secretary of State implemented a postcard program in 2004 that confused numerous entities with the filing of the Florida Annual Report. The officers of this

Taxpayer speak English as a second language and do not read English well at all; their native language is Spanish.

In the case at hand, taxpayer utilized the services of an outside independent accountant that failed to file numerous tax and annual reports. He was replaced, and, did not cooperate with the taxpayer in the transition. We took over this account and received a box of files with past-due notices, receipts, deposits and non-current financials from the prior accountant. The officers and employees did not receive the Annual Report that the prior accountant presumably downloaded.

But for taxpayer's need to download these forms and being forced to rely upon an outside professional, the Florida Annual Report would have been timely filed. In past year, taxpayer's officers would have received the normal annual report, and, given a signed copy to its in-house bookkeeper to timely filing and payment. Your new postcard system forced this taxpayer to rely upon an outside professional that did not due his job. And, more importantly, did not give the Annual Report to the taxpayer. This prior accountant, who was subsequently fired, convinced the taxpayer's Spanish speaking offices to sign a back-dated form to protect the prior accountant's malfeasance.

As your system is set up, anyone can download any corporation's Annual Report. Your relief provisions provide for abatement if the report is not received by the taxpayer, as is the case in this instance.

Hurricane Relief

The only asset of this corporation is located in St. Lucie county: Two hurricanes directly affected the property of this company. This taxpayer was adversely affected by both hurricanes. Its books and records were boxed up and stored during the two hurricanes. The offices were closed. The officers and employees of the taxpayer were forced to evacuate. And, more importantly, our firm was unable to obtain the books, records and boxes of past-due notices, filings and bills until after the hurricanes.

Again, please reconsider your denial of the request to abate the \$600.00 2004 For Profit Corporation Annual Report late filing penalty for this company.
