ARTICLE 3. ADDRESS. The principal place of business and mailing address of this corporation shall be 1807 Premier Row, Orlando, FL 32809.


ARTICLE 4. STOCK. The corporation is authorized to have outstanding at any one time 1000 shares of stock at no par value.


