AMENDMENTS

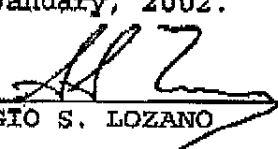

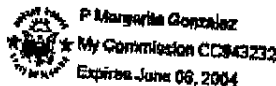
