

ARTICLES OF INCORPORATION OF  
ABOVE AND BEYOND CARPET CARE AND RESTORATION, INC.

1. Name. The name of the corporation is: ABOVE AND BEYOND CARPET CARE AND RESTORATION, INC.
2. Purpose. The corporation may engage in any legal business.
