In compliance with Chapter 607 and/or Chapter 621, F.S. (Profit)

### ***Article I Name***

The name of the corporation shall be:

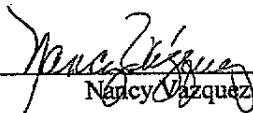
**Article X Amendment**

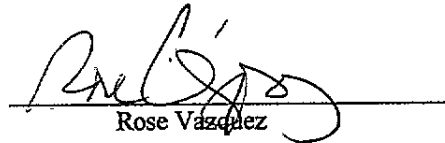

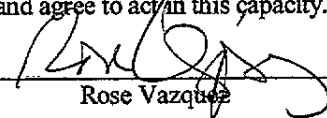
