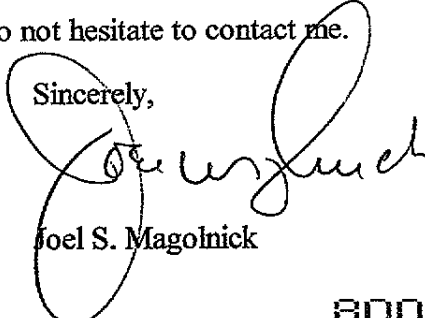

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. The name of the corporation is:

GanoMas, Inc.

2. The period of its duration is perpetual.

3. The purpose is to operate a business enterprise as permitted under the laws of the State of Florida and the United States.

4. The corporation shall have authority to issue 1000 shares, all of one class, \$.01 par value.

5. The address of its principal place of business is 1111 Brickell Avenue, Suite 2050, Miami, Florida 33131.

6. The initial registered agent of the corporation is Joel S. Magolnick, 1111 Brickell Avenue, Suite 2050, Miami, Florida 33131.

7. The number of directors constituting its initial board of directors is (1). The names and addresses of the officers and directors of this corporation, who shall hold office for the first corporate year or until their successors are chosen are:

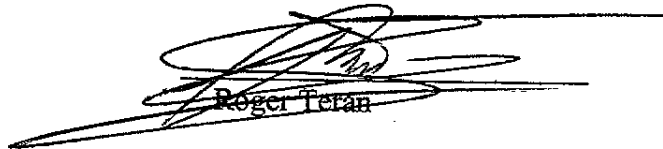

8. Where shareholder approval is required for any action, each shareholder shall be entitled to vote equal to the number of shares he or she may own. The approval of any action shall require the affirmative vote of not less than fifty-one percent (51%) of all of the issued and outstanding shares.

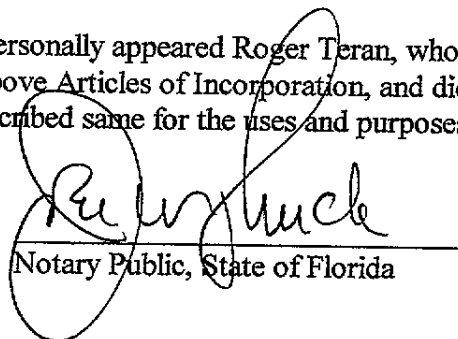

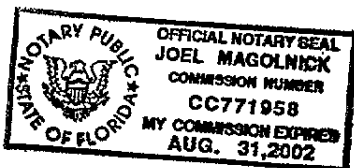

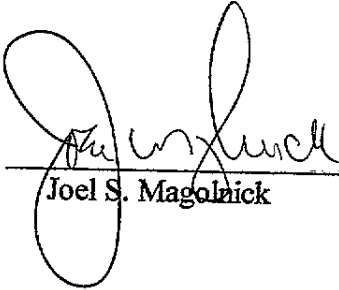
