ARTICLES OF INCORPORATION OF RANDALL ELECTRICAL CONTRACTORS OF CENTRAL FLORIDA, INC.

The undersigned acting as incorporator of this corporation pursuant to Chapter 607 of the Florida statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation.

ARTICLE I- NAME AND ADDRESS OF CORPORATION

The name of the corporation shall be Randall Electrical Contractors of Central Florida, Inc. The address of the corporation shall be 886 South Dillard St., Winter Garden, FL 34787.

ARTICLE II-TERM OF EXISTENCE

This corporation shall exist perpetually.

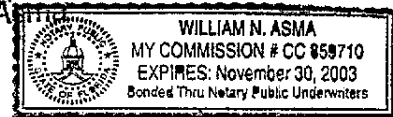
