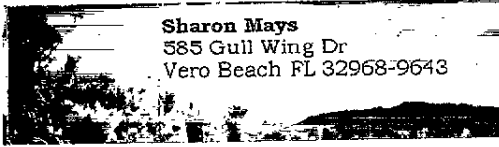

ARTICLES OF INCORPORATION  
OF

SHARON D. GASKIN, INC.

ARTICLE ONE-NAME

The name of the corporation is SHARON D. GASKIN, INC., whose principal office and mailing address is 585 GULLWING DRIVE, VERO BEACH, FLORIDA, 32968.

ARTICLE TWO-PURPOSE

This corporation is organized for the purpose of engaging in any legal business permitted by the State of Florida.

ARTICLE THREE-CAPITAL STOCK

This corporation is authorized to issue one thousand shares of one dollar par value common stock, which shall be designated "Common Shares".

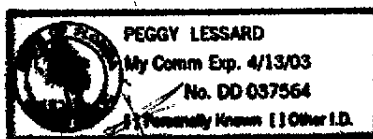
