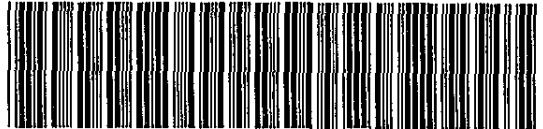



WHEREAS this Corporation was formed, organized, by Julio R. Acevedo and was operated by Sandra M. Duran and Rafael Duran, her husband; and

WHEREAS Sandra M. Duran and Rafael Duran have acted contrary to the best interests of the corporation by, inter alia, failing to pay lease payment resulting in a lawsuit being filed against the corporation and against a director in his individual capacity; and

WHEREAS the directors of this Corporation no longer desire to maintain it's separate existence; and


WHEREAS all debts of this Corporation have been paid or provision for payment made; and
