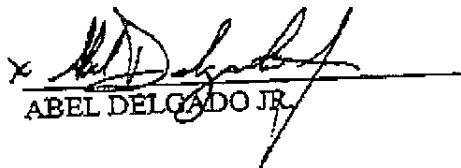
ARTICLE XI

ARTICLE XII

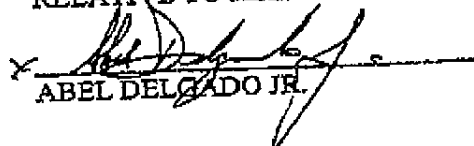
