ARTICLE IV. INITIAL REGISTERED AGENT AND OFFICE.

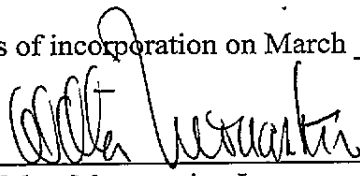

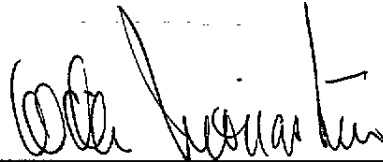
**DESIGNATION AND ACCEPTANCE OF REGISTERED AGENT
