The undersigned, subscriber to these Articles of Incorporation, a natural person competent to contract as a real estate appraiser, hereby presents these articles for formation of a corporation under the Professional Service Corporation Act and other laws of the State of Florida.

ARTICLE I

NAME OF CORPORATION

The name of this corporation is REBECCA CAIRONE, P.A.

ARTICLE II

PRINCIPAL OFFICE

The principal office of this corporation shall be at 4625 Briarcliff Lane, Coconut Creek, Fl. 33066.

ARTICLE III

PURPOSE

The corporation is formed for the following purposes:

A. To engage in every phase and aspect of the business of rendering the same professional services to the public that a real estate appraiser, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed under the laws of the State of Florida to prepare real estate appraisals therein.

- B. To invest the funds of this corporation in real estate, mortgages, stocks, bonds or any other type of investment, and to own real and personal property necessary for the rendering of professional services.
- C. To do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendment thereof, necessary or incidental to the protection and benefit of the corporation, and in general, either alone or in association with other corporations, firms, or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purposes or the attainment of the objects or the furtherance of such purposes or objects of this corporation.
- D. The transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.
- E. The foregoing paragraphs shall be construed as enumerating both objects and purposes of this corporation; and it is hereby expressly provided that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of this corporation otherwise permitted by law.

ARTICLE IV

CAPITAL STOCK

ARTICLE VII

DIRECTORS

This corporation shall have one (1) director initially. The number of directors may either be increased or diminished from time to time in accordance with By-Laws adopted by the stockholders but shall never be less than one (1) director, provided, however, that all corporate powers shall be exercised by the stockholders and the business and affairs of the corporation shall be managed under the direction of the stockholders in accordance with By-Laws adopted by the stockholders and provided further that each director of this corporation shall be licensed to prepare real estate appraisals in the State of Florida.
