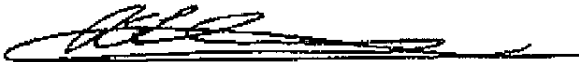
ARTICLE XI. AMENDMENTS

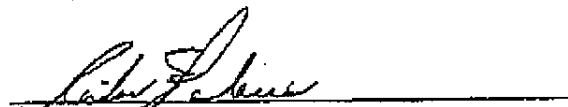
ARTICLE XII.
