# ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation of a professional service corporation, being a natural person competent to contract, and admitted to practice as a certified public accountant under the laws of the State of Florida, desires to establish a professional service corporation under the laws of the State of Florida.

# ARTICLE I

<u>NAME</u>

The name of this corporation is: Mary K. Foreman, P.A.

# ARTICLE II

# **NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is: the practice of certified public accounting by certified public accountants licensed to practice in the State of Florida, the furnishing of related professional services and the lease or purchase of such real and personal property as is necessary for the rendering of this practice;

The investment of funds in real estate, mortgages, stocks, bonds, or any other type of investments;

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness and execute such mortgages, transfers of corporate property, or other instruments to secure the payment of corporate indebtedness as required;

To purchase the corporate assets of, merge, or consolidate with any other domestic corporation engaged in the same character of business;

The redemption, purchase, retention, sale and transfer of its own capital stock; and the creation of employee benefit plans and trusts incidental thereto.

#### **ARTICLE III**

#### CAPITAL STOCK

#### <u>AMENDMENT</u>

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the board of directors, proposed by them to the stockholders and approved at a stockholders' meeting by a majority of the stock entitled to vote thereon. Alternatively, all the directors and all the stockholders may sign a written statement manifesting their intention that a certain amendment of these Articles of Incorporation be made.

#### ARTICLE XII

#### LIMITATIONS ON CORPORATE STOCK OWNERSHIP

- 1. No one other than an individual who is duly licensed as a certified public accountant under the laws of the State of Florida may own any corporate stock in this corporation; nor may any stockholder enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of the stockholder's stock.
- 2. If any officer, stockholder, agent or employee of this corporation who has been rendering professional services to the public becomes legally disqualified to render such services within the State of Florida or accepts employment that, pursuant to existing law, places restrictions or limitations upon that person's continued rendering of such professional services, that person shall sever all employment with, and financial interests in, the corporation forthwith.
- 3. No stockholder of the corporation may sell or transfer stock in this corporation except to another individual who is eligible to be a stockholder of the

corporation.
