In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is TNCF Enterprises, Inc.

ARTICLE II

The street address of the principal office of the Corporation is 5637 Whisperwood Blvd., #601, Naples, FL 34110

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 1000, par value \$1.00 per share, all of which shall be Common Shares. 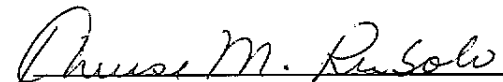

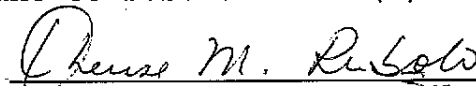
The Corporation shall indemnify its directors, officers,
