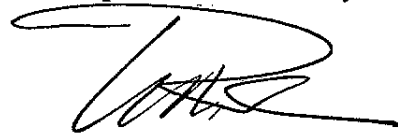
ARTICLE VI – AMENDMENT

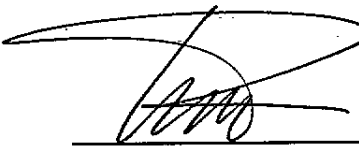

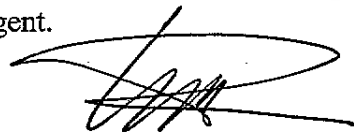
