ARTICLES OF INCORPORATION OF MARTONIO PINTO, INC.

THE UNDERSIGNED, acting as sole incorporator of MARTONIO PINTO-INC., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I
