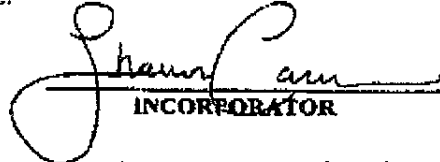
**ARTICLE VIII: INCORPORATOR**
