6. The initial Board of Directors shall have two members whose names and addresses are as follows:

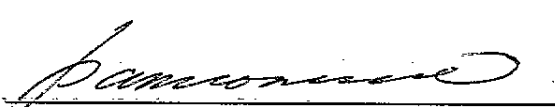

The number of directors may be raised or lowered by amendment of the bylaws of the corporation but shall in no case be less than one.

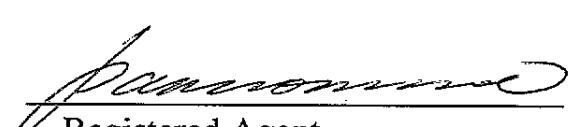
