The undersigned, acting as Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. Name. The name of this corporation is **MAGNOLIA SQUARE TREASURES, INC.**

2. Duration. The period of its duration is perpetual.

3. Purpose. The purpose is to engage in any activities or business permitted under the laws of the United States and Florida.

4. Capital Stock. This corporation is authorized to issue one thousand (1,000) shares, all of one class, at ten cents (\$0.10) par value.
