**AMENDED AND RESTATED
ARTICLES OF INCORPORATION
OF
APPLICATIONS CONSULTING TRAINING SOLUTIONS, INC.
(A Florida Corporation)**

Pursuant to the provisions of Section 607.1007 of the Florida Business Corporation Act, the undersigned hereby adopts the following Amended and Restated Articles of Incorporation:

1. The name of the corporation is APPLICATIONS CONSULTING TRAINING SOLUTIONS, INC. (the "Corporation"). The date of filing the original Articles of Incorporation with the Secretary of State was April 30, 2002.

2. The Amended and Restated Articles of Incorporation were unanimously adopted and approved by the Board of Directors and the Shareholders of the Corporation on Oct 10, 2014, in accordance with Sections 607.1003, 607.1006, and 607.1007 of the Florida Business Corporation Act.

The Articles of Incorporation are hereby amended and restated in their entirety as follows:

ARTICLE I

The name of the corporation is APPLICATIONS CONSULTING TRAINING SOLUTIONS, INC. (hereinafter the "Corporation").

ARTICLE II

The address of the principal office and mailing address of the Corporation is 100 North Laura Street, Suite 700, Jacksonville, Florida 32202.

ARTICLE III

The purpose for which the Corporation is organized is to engage in any lawful act or activity for which a corporation may be organized under the Florida Business Corporation Act.

ARTICLE IV

This Corporation shall have the authority to issue One Hundred (100) shares of Common Stock having a par value of \$1.00 per share. Each issued and outstanding share of common

stock shall be entitled to one vote on each matter submitted to a vote at a meeting of the shareholders.

ARTICLE V

The street address of the Corporation's registered office is 1200 South Pine Island Road, Plantation, Florida 33324 and the name of its registered agent at such office is NRAI Services, Inc.

ARTICLE VI

This Corporation shall indemnify and shall advance expenses on behalf of its officers and directors to the fullest extent not prohibited by applicable law.
