AMENDED AND RESTATED ARTICLES OF INCORPORATION OF APPLICATIONS CONSULTING TRAINING SOLUTIONS, INC. (A Florida Corporation)

Pursuant to the provisions of Section 607,1007 of the Florida Business Corporation Act, the undersigned hereby adopts the following Amended and Restated Articles of Incorporation:

- 1. The name of the corporation is APPLICATIONS CONSULTING TRAINING SOLUTIONS, INC. (the "Corporation"). The date of filing the original Articles of Incorporation with the Secretary of State was April 30, 2002.
