like force and effect as if he were not such a director or officer of such other corporation, or not so interested.

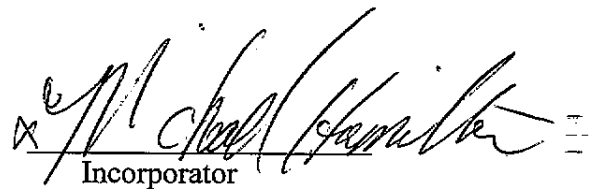
ARTICLE X

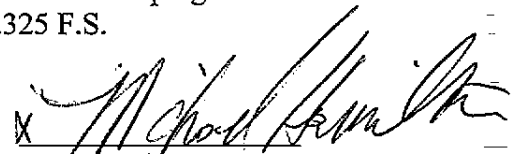
