ARTICLE I -- NAME

The name of the corporation is **PERI KIROS, P.A.**

ARTICLE II -- DURATION

ARTICLE IX -- INDEMNIFICATION

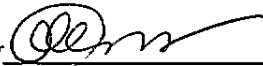
The corporation shall indemnify any Officer or Director or any former officer or director, to the full extent permitted by law.

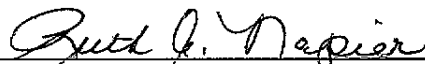

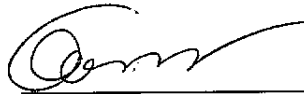
