# ARTICLES OF INCORPORATION OF CUSTOM BUILDERS BY GRUBBS, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Act hereby adopt the following Articles of Incorporation.

# ARTICLE I

#### <u>Name</u>

The name of the Corporation shall be: CUSTOM BUILDERS BY GRUBBS, INC.

#### ARTICLE II

# Nature of Business

The general nature of the business and the objects and purposes to be transacted and carried on are: To do any and all legal business allowed by the laws of the State of Florida and of the United States.

The right may also be waived by affirmation of a written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.




