To Whom It May Concern,

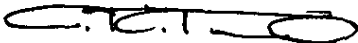
Please find my corporation's 2003 filing of the Uniform Business Report. This report is being filed beyond the normal filing deadline. Due to the following circumstances, I would like to request a waiver of the delayed filing penalty.

I am a new business owner and created my corporation only last year. Unfortunately, I am only now learning of the annual state administrative requirements. Although this is no excuse, it resulted in this filing delay due to an extended absence for military requirements earlier this year.
