ARTICLES OF INCORPORATION OF LITTLEBIT ACCESSORIES, INC.

ARTICLE I. NAME

The name of the Corporation is: LITTLEBIT ACCESSORIES, INC.

ARTICLE II. PRINCIPAL OFFICE
