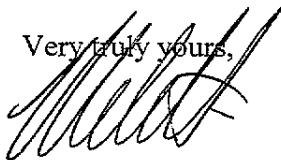

**ARTICLES OF INCORPORATION
OF
ALAN D. HOLT, A.S.L.A., LANDSCAPE ARCHITECT, P.A.**

In compliance with the requirements of F.S. Chapter 621, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is ALAN D. HOLT, A.S.L.A., LANDSCAPE ARCHITECT, P.A.

ARTICLE II

The existence of the corporation shall begin on the date of filing.

ARTICLE III

The street address of the principal office and mailing address of the Corporation is 433 Harrison Avenue, Panama City, Florida 32401.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1000. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE IX

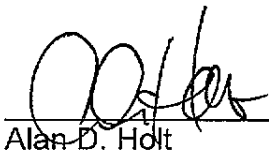
This corporation is organized for the following purposes:

B. To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this corporation.

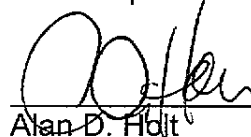
C. The professional services of this corporation shall be carried out only through executive officers, employees, and agents, each of whom has been licensed to practice landscape architecture in the State of Florida.
