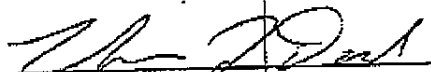

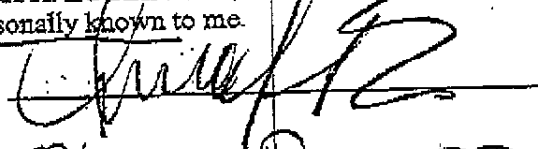
1. The name of the corporation is Jack K. Zollinger, Inc.
